

Sezzjoni B / Section B

1. Applikazzjonijiet minn persuni li jkollhom dejn għadu pendent fuq il-kont tagħhom ma jiġux aċċettati.
Applications from persons who have outstanding debts on their accounts will not be accepted.

2. M'hemmx spejjeż involuti għaċ-ċaqlieq ta' meter tal-ilma b'distanza qasira perpendiculari għall-main (jiġifieri ma jkunx hemm bżonn ta' meter ġdid). Meta ċ-ċaqlieq tal-meter ikun f'distanza akbar mill-main, jiġu applikati l-istess tariffi bħal daqs li kieku se jitwaħħal servizz ġdid.

Replacement of water pipes or shifting your water meter by a short distance perpendicular to the main (requiring no new connection) will not involve a charge. When a new connection is required the same charges as for a new service will be applicable.
